The facility has been in continuous operation for 73 years. They were recognized by the Texas Rural Association with a “Community that Cares” award and again by the Texas Medical Foundation with the “Award of Excellence in Healthcare Quality Improvement.”

**The successful candidate should have proven accounting, analysis, financial, reporting including cost reporting and reimbursement expertise, as well as familiarity with federal grant reporting requirements;** should be able to exhibit excellent management skills; take the initiative to complete critical tasks and functions; be able to work collaboratively with others; be willing to teach, mentor and grow others. The candidate’s financial ability should include directing and/or preparing and providing current financial reports and summaries, creating/providing funding forecasts necessary to support planned future growth; completing and submitting all required governmental reporting, and analyzing and advising appropriate costs assignment to maximize organization return on activities, investments and efforts.
