## NOTICE OF PUBLIC HEARING ON TAX INCREASE

A tax rate of \$0.215376 per \$100 valuation has been proposed by the governing body of Chambers County Public Hospital District No. 1.

PROPOSED TAX RATE	\$0.215376 per \$100
NO-NEW-REVENUE TAX RATE	\$0.198149 per \$100
VOTER-APPROVAL TAX RATE	\$0.215376 per \$100

The no-new-revenue tax rate is the tax rate for the 2024 tax year that will raise the same amount of property tax revenue for Chambers County Public Hospital District No. 1 from the same properties in both the 2023 tax year and the 2024 tax year.

The voter-approval rate is the highest tax rate that Chambers County Public Hospital District No. 1 may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that Chambers County Public Hospital District No. 1 is proposing to increase property taxes for the 2024 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON September 26, 2024 AT 5:30 PM AT Bayside Community Hospital Conference Room, 200 Hospital Drive, Anahuac, Texas 77514.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, Chambers County Public Hospital District No. 1 is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Board of Directors of Chambers County Public Hospital District No. 1 at their offices or by attending the public hearing mentioned above.
